## **How we use your personal data**

EU General Data Protection Regulation (GDPR)

By joining the Society, we need to collect some items of personal data in order to provide you with your membership. This personal data we collect is: your name(s), your address, your phone number and if you provide it, your email address. We use this information for the following purposes:

- To provide you with and maintain your membership to the Society
- To keep in touch with you about your membership of the Society and the activities of the Society

We will only keep your data for as long as you are a member of the Society. When your membership lapses or you cancel your membership, all the data we hold on you is deleted

We do not sell your data or pass it on to any third parties, with the following exception:

- If you opt in to receive our email newsletters, we will share your name and email address with MailChimp, our mailing list provider. You can unsubscribe from these emails at any time (via the links in emails sent via MailChimp, or by contacting us) and when if you do so, the supplied personal data will be deleted from MailChimp's systems

You have a right to see the information we hold on you at any time. The easiest way to do this is to log in to your online account (if you have one). Alternatively, you can contact the Secretary and we'll be happy to send you a copy of your data. We also send you a copy of your membership record once a year, when you are invited to renew your membership

You have a right to have any incorrect data we hold on you corrected. You can do this by logging in to your online account, or by contacting the Secretary

Finally, you have a right to request we delete any personal data we hold on you. This is also known as your right to be forgotten. Please contact us if you would like to exercise this right, however please be aware that we may not be able to continue providing you with membership to the Society if you request we delete any data we hold on you.
